Transportation: Children in **Redding** and **Ridgefield** will be picked up/delivered as close to home as deemed feasible by the Camp. Campers may be required to meet the bus at a central location (such as a school parking lot or a cul-de-sac). Transportation from all other towns will be from central locations. Use of central pick-up points reduces the length of time your child is on the bus and enhances our ability to manage bus transportation to and from Camp. In the morning, all bus routes start at a point furthest from camp. In the afternoon, the bus will leave camp and work its way back to the furthest point. The first stop in the morning will be the last stop in the afternoon.
